The Promoter / Representative of the Promoter remained absent.

ORDER

18th April 2023 (Through Video Conferencing)

- The MahaRERA Authority had issued a show cause notice dated 28/03/2023 to the Promoter above named for publishing an advertisement dated 22/03/2023, in the Maharashtra Times Newspaper, without mentioning the MahaRERA project registration number, in regards to the project "Suman Co-Operative Housing Society Limited" bearing MahaRERA registration no. P52100049422, situated in Pune.
- 2. The promoter by its reply dated 03/04/2023, to the said show cause notice dated 28/03/2023, had submitted that the said advertisement was the first newspaper advertisement and inadvertently due to oversight issued the advertisement without mentioning the MahaRERA registration number.
- 3. In this regard, a hearing was scheduled on 17/04/2023 through video conferencing as per the MahaRERA Circular No. 27/2020 and

MahaRERA Order No. 593/2023, when the promoter appeared through its representative and made its submissions.

- 4. During the hearing, the Promoter remained absent.
- In view of the above, necessary orders will be passed on the basis of the submissions made by the Promoter in the reply dated 03/04/2023, entirely at the Promoter's risk as to cost and consequences.
- In this regard, it is necessary to peruse the provision of section 11(2) of the RERA which reads as under:

"11(2) The advertisement or prospectus issued or published by the promoter shall mention prominently the website address of the Authority, wherein all details of the registered project have been entered and include the registration number obtained from the Authority and such other matters incidental thereto."

- 7. From the plain reading of section 11(2), the promoter is under obligation to mention prominently, the registration number of the project in the advertisements or the prospectus issued by it. However, in the present case, the Promoter had published a quarter-sized advertisement in the Maharashtra Times newspaper dated 22/03/2023. Further, the Promoter had failed to publish the MahaRERA registration number in the said advertisement dated 22/03/2023 issued by it in the above-named newspaper. Hence, the Promoter is in violation of section 11(2) of RERA.
- In view of the above a penalty of Rs. 50,000/- under section 61 of Page 2 of 3

the RERA, is imposed upon the promoter for violation of section 11(2).

- 9. The said penalty shall be payable by the promoter within a period of 15 days from the date of this order, failing which a further penalty of Rs. 1,000/- per day would be imposed till compliance.
- 10. The Technical and Finance Department of the MahaRERA authority shall verify the payment of the said penalty before processing any applications viz. extension, correction, change of name etc., with respect to the said project.
- 11. With the above directions, the present case stands disposed of.
