
Heard the arguments of the Promoter.

The Promoter had published an advertisement on the Instagram platform dated 12.02.2024 in respect of their real estate project "Promesa Castor" situated at Mumbai, wherein the Project Registration number and the QR code was not incorporated in the said advertisement.
