Total Penalty of Rs. 20,000/- (i.e. Penalty of Rs.10,000/- under Section 61 of the Act, 2016 for violation of Section 11(2) of the RERA Act, 2016 and Penalty of Rs.10,000/- for breach of directions issued vide MahaRERA Order No.46/2023, dated 29.05.2023 r.w. MahaRERA Order No.46A/2023, dated 25.07.2023) has been imposed against the respondent-promoter. The aforesaid penalty shall be payable by the respondent within 15 days from the date of enforcing penalty, failing which respondent shall be liable to penalty of Rs.1000/- per day, in addition, till the compliance. The Technical and Finance Department of the MahaRERA Authority shall verify the payment of the said penalty before processing any applications by promoter for extension, corrections, change of name etc., with respect to the said project.
